#### Additional Bank Fee Charge

#### Immigration New Zealand Proof of Funds Requirement

From 31 July 2022, the amount of funds a student will need to show that they have access to will be NZD\$20,000.00 per annum (pro rata for short courses). It is not the start date of the course in this case that dictates the amount of money required, it's the date the application for a visa is lodged. The figure applies to student visa applications that are lodged on, or after 31 July 2022.

#### Other Important Notes

Costs for textbooks, stationery, additional registration fees, equipment and academic attire for graduation are all the responsibility of the student. These costs may be up to \$1,000.00. Please note that your fees for continuing years of study may be subject to annual increases. As a guide, in previous years, this increase has been up to 5%.
