

Guidance Notes on how to fill the NoE form

- ALWAYS download the LATEST VERSION of the NoE form MSF 4274 from the MCA website using Google search. Type in the Google search box: MSF 4274 PDF. Download the NoE form.
- Take a black and white printout of the form.
- The form is to be filled up in **CAPITAL LETTERS** with **BLACK INK**.
- A sample filled up form is attached with DUMMY DATA. This is for reference only to help you fill the NoE form.
- If your home address does not have good courier service, please mention an alternate address on Page 1 of the NoE form where the courier service is good for e.g. Mumbai / Delhi, etc. If you hold a UK OOW CoC, the MCA will accept your documents by email at present. However, if your OOW CoC is not from the UK and this is your first UK CoC for which you are applying for an NoE, then you need to send all documents in ORIGINALS only to the MCA. The MCA UK address is given in the NoE form first page at the top.
- In Page 2 of the NoE form, if you do not know the Official Number of the vessel, you can fill the IMO Number. If you Google the vessel details by putting the ships name, you will likely get the IMO number of the ship. If you cant get the IMO number also, then leave this column blank. Put the signing on and signing off dates as per the CDC and not as per company sea-time letter / master testimonials / passport in-case there

is any discrepancy / error between dates put on the CDC and that put on the Master's testimonials / company sea-time letter.

- In page 3 of the NoE form at the top i.e. Section 4, please mention the details of your existing CoC. Kindly note that your existing STCW II/1 OOW CoC should be valid (or you will have to revalidate that) whilst applying for your UK Chief Mates NoE.
- In page 3, section 4A, a list of documents are mentioned which have to be submitted along with your NoE application. The Medical Fitness Certificate from the DG Shipping doctor, India has to be in the Annexure IV format only. For NoE application, it is NOT necessary that you should be having the MCA, UK approved STCW advanced courses. However, all the advanced courses will be required to be submitted whilst applying for your CoC.
- In page 4 of the NoE form, under Section 5 DECLARATION, put your signature as per your passport within the rectangular box. Do not paste your photograph in the square box which mentions FOR OFFICIAL USE ONLY. In the DATE SECTION, put the date on which you signed in the column above.
- In page 4 of the NoE form, under Section 6 COUNTER SIGNATURE, you need to put details of someone who knows you in a professional capacity for e.g doctor, lawyer, teacher, bank manager, captain, superintendent, fleet manager, etc. That person cannot be your friend or relative and must know you in a professional capacity. He will need to fill up and sign / date in section 6 of the NoE form and also explain that he knows you in what professional capacity. He will also sign behind one of the photographs, see sample photograph section for more details.
- The payment has to be done using your debit / credit card only. No cash or DD are accepted. The link for payment is on page 5 of the NoE form. After making the payment, you will receive an acknowledgement receipt in email. Take a printout of the receipt and it is to be sent to the MCA along with your other NoE supporting documents by post or as scanned copy. The payment amount of GBP 220 is inclusive of NoE return courier charges. You can also use the credit / debit card of your friend / relative for making the online payment if your card is not working.

- The processing time for NoE is 4 weeks. In some cases, it may take longer than that depending upon extenuating factors like Covid, etc., and the workload on the MCA in terms of pending NoE applications.
- The following are the documents to be sent to the MCA by courier for NoE application. If you already hold a UK OOW CoC, for the interim, the MCA will accept scanned copies of the above documents.  - Refresher course of PST and FPFF if done in the last 5 years.
