- Employer Sponsored applicants must provide evidence of genuine access to funds:
 - Proposed course of study should be consistent with their current role with the sponsoring employer, and
 - demonstrate a genuine need within this business for the applicant to study the proposed course and how this course will meet this need; and
 - more than enough financial capacity for the employer to sustain their business as well as sponsor the applicant.
- All documents provided must be recent and attested true copy by the agent.
